

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0269

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 18, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for committing a disqualifying act under the Department’s drug, cannabis, and alcohol adjudication policy, and that claimant therefore was disqualified from receiving unemployment insurance benefits effective October 19, 2025 (decision # L0014837056).¹ Claimant filed a timely request for hearing. On February 5, 2026, ALJ Janzen conducted a hearing, and on February 6, 2026, issued Order No. 26-UI-319515, affirming decision # L0014837056. On February 26, 2026, Order No. 26-UI-319515 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 17, 2026, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 26-UI-319515, mailed to claimant on February 6, 2026, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 26-UI-319515 at 6. Order No. 26-UI-319515 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before February 26, 2026 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 26-UI-319515 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-319515 was due by February 26, 2026. Because claimant did not file his application for review until March 17, 2026, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances, if any, that prevented him from filing the application for review by the February 26, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed March 17, 2026 is dismissed. Order No. 26-UI-319515 remains undisturbed.
