

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0273**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On October 27, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving unemployment insurance benefits effective July 20, 2025 (decision # L0013653567).<sup>1</sup> On November 17, 2025, decision # L0013653567 became final without claimant having filed a request for hearing. On December 12, 2025, claimant filed a late request for hearing on decision # L0013653567.

ALJ Kangas considered claimant's request, and on February 5, 2026 issued Order No. 26-UI-319378, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 19, 2026. On February 19, 2026, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire, and on February 26, 2026 issued Order No. 26-UI-321627, canceling Order No. 26-UI-319378, re-dismissing claimant's request for hearing on decision # L0013653567 as late without good cause, and leaving that decision undisturbed. On March 18, 2026, claimant filed a timely application for review of Order No. 26-UI-321627 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant did not state that they provided a copy of their argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the record before the ALJ at OAH by including it with their timely response to the appellant questionnaire, as required by OAR 471-041-0090 (May 13, 2019). Under ORS 657.275(2) and OAR 471-041-0090, EAB did not consider claimant's new information.

<sup>1</sup> Decision # L0013653567 stated that claimant was denied benefits from July 20, 2025 to September 19, 2026. However, decision # L0013653567 should have stated that claimant was disqualified from receiving benefits beginning Sunday, July 20, 2025 and until they earned four times their weekly benefit amount. See ORS 657.176.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-321627’s findings of fact, reasoning, and conclusion that claimant’s late request for hearing should be dismissed. Order No. 26-UI-321627 is adopted. *See* ORS 657.275(2).

**DECISION:** Order No. 26-UI-321627 is affirmed.
