

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0280**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** November 13, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and therefore was disqualified from receiving unemployment insurance benefits effective September 28, 2025 (decision # L0014061255).<sup>1</sup> Claimant filed a timely request for hearing. On February 5, 2026, ALJ Scott conducted a hearing. On February 10, 2026, ALJ Scott issued Order No. 26-UI-319809, which the ALJ then re-issued on March 10, 2026 as Amended Order No. 26-UI-322952,<sup>2</sup> affirming decision # L0014061255. On March 20, 2026, claimant filed an application for review of Order No. 26-UI-322952 with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-322952's findings of fact, reasoning, and conclusion that claimant was discharged for misconduct and therefore was disqualified from receiving unemployment insurance benefits effective September 28, 2025. Order No. 26-UI-322952 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-322952 is affirmed.
