

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0281**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On January 27, 2026 the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and therefore claimant was disqualified from receiving unemployment insurance benefits effective December 14, 2025 (decision # L0015777726).<sup>1</sup> Claimant filed a timely request for hearing. On March 9, 2026, ALJ Naylor conducted a hearing, and on March 17, 2026 issued Order No. 26-UI-323886, reversing decision # L0015777726 by concluding that the employer discharged claimant, but not for misconduct, and that claimant was not disqualified from receiving benefits based on the work separation. On March 23, 2026, the employer filed an application for review of Order No. 26-UI-323886 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing. EAB considered any parts of claimant's argument that were based on the hearing record.

<sup>1</sup> Decision # L0015777726 stated that claimant was denied benefits from December 14, 2025 to December 12, 2026. However, decision # L0015777726 should have said that claimant was disqualified from receiving benefits beginning Sunday, December 14, 2025 and until she earned four times her weekly benefit amount. *See* ORS 657.176.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-323886’s findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. Order No. 26-UI-323886 is **adopted**. *See* ORS 657.275(2).

**DECISION:** Order No. 26-UI-323886 is affirmed.
