

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0294

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 23, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits beginning December 14, 2025, (decision # L0014935660). On January 12, 2026, decision # L0014935660 became final without claimant having filed a request for hearing. On January 17, 2026, claimant filed a late request for hearing. ALJ Kangas considered the request, and on March 6, 2026 issued Order No. 26-UI-322727, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 20, 2026. On March 24, 2026, the Department issued decision # L0016706820, cancelling decision # L0014935660 and concluding that claimant was eligible for benefits based on having completed their work registration successfully. On March 25, 2026, claimant filed an application for review of Order No. 26-UI-322727 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of decision # L0016706820, and screenshots submitted with claimant's application for review, which have been marked as EAB Exhibits 1 and 2, respectively, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibits will remain in the record.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 26-UI-322727 presents no justiciable controversy and is dismissed.

On March 25, 2026, claimant filed with EAB an application for review of an order dismissing his late request for hearing on decision # L0014935660. However, on March 24, 2026, the Department had issued decision # L0016706820, which cancelled decision # L0014935660 and concluded that claimant was eligible to receive benefits based on having completed their work registration successfully. This administrative decision was fully favorable to claimant.

Oregon courts follow the principle that a review on appeal may only be provided for justiciable controversies. *See, e.g., Gortmaker v. Seaton*, 252 Or. 440, 442, 450 P.2d 547 (1969). A justiciable controversy exists when the interests of the parties to the action conflict with each other, and the appeal will have some practical effect on the rights of the parties to the controversy. *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). To show a practical effect on their rights, an appellant must seek “substantive relief” through their appeal. *Krisor v. Henry*, 256 Or. App. 56, 300 P.3d 199 (Or. Ct. App. 2013).

Because the administrative decision denying claimant benefits has been cancelled, EAB’s review of this matter could not provide substantive relief to the appellant, and such review would have no practical effect on the appellant’s rights.¹ Accordingly, there is no justiciable controversy before EAB based upon claimant’s application for review. Because the case before EAB presents no justiciable controversy, the application for review of Order No. 26-UI-322727 is dismissed and Order No. 26-UI-322727 remains undisturbed.

DECISION: The application for review filed March 25, 2026 is dismissed. Order No. 26-UI-322727 remains undisturbed.

¹ The Department’s records show that claimant has not been paid benefits for the weeks of January 4, 2026 through January 17, 2026 (weeks 01-26 and 02-26), possibly due to a clerical error involving either the administrative decisions in this matter or an unrelated administrative decision regarding claimant’s completion of identity verification. Claimant may wish to contact the Department regarding this issue and the payment of benefits for those weeks. Claimant may request reconsideration of EAB’s decision in this matter if the Department asserts that payment for those weeks is denied based on claimant having failed to timely register for work. *See* ORS 657.290(3). Claimant may also pursue further appeal of the identity verification administrative decision if the Department asserts that decision is the basis for denying benefits for those weeks.
