

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0298

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On October 7, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 17, 2025 (decision # L0013248223).¹ Claimant filed a timely request for hearing. On December 23, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 2, 2026. On January 2, 2026, claimant failed to appear at the hearing, and ALJ Murray issued Order No. 26-UI-315982, dismissing claimant's request for hearing due to her failure to appear.

On January 5, 2026 claimant filed a timely request to reopen the hearing. OAH considered this request, and on March 19, 2026 ALJ Murray conducted a hearing and issued Order No. 26-UI-324426, denying the request and leaving Order No. 26-UI-315982 and decision # L0013248223 undisturbed. On March 25, 2026, claimant filed an application for review of Order No. 26-UI-324426 with EAB.

WRITTEN ARGUMENT: Claimant did not state that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019). Claimant's argument also was not relevant and material to EAB's determination of whether there was good cause to reopen the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing.

Claimant also asserted in her written argument that the hearing proceedings were unfair or the ALJ was biased. EAB reviewed the entire hearing record, which shows that the ALJ inquired fully into the matters at issue, which was whether there was good cause to reopen the hearing, and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4), and OAR 471-040-

¹ Decision # L0013248223 stated that claimant was denied benefits from August 17, 2025 to August 22, 2026. However, decision # L0013248223 should have stated that claimant was disqualified from receiving benefits beginning August 17, 2025 and until she earned four times her weekly benefit amount. *See* ORS 657.176.

0025(1) (August 1, 2004). Because the ALJ did not find there was good cause to reopen the hearing, testimony and evidence related to claimant's work separation from the employer was not reached.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-324426's findings of fact, reasoning, and denial of claimant's request to reopen, and leaving Order No. 26-UI-315982 and decision # L0013248223 undisturbed. Order No. 26-UI-324426 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-324426 is affirmed.
