

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0300

Affirmed
Disqualification

PROCEDURAL HISTORY: On December 30, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving benefits effective October 19, 2025 (decision # L001507731).¹ Claimant filed a timely request for hearing. On March 2, 2026, ALJ Hall conducted a hearing, and on March 10, 2026 issued Order No. 26-UI-323074, affirming decision # L001507731. On March 27, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-323074's findings of fact, reasoning, and conclusion that claimant quit work without good cause and was disqualified from receiving benefits. Order No. 26-UI-323074 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-323074 is affirmed.
