

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0303

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 16, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to verify their identity in accordance with Department rules, and therefore was ineligible for unemployment insurance benefits effective September 15, 2025 (decision # L0012912938). On October 6, 2025, decision # L0012912938 became final without claimant having filed a request for hearing. On January 13, 2026, claimant filed a late request for hearing on decision # L0012912938.

ALJ Kangas considered claimant's request, and on March 12, 2026 issued Order No. 26-UI-323383, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 26, 2026. On March 25, 2026, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 26-UI-323383 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 26-UI-323383 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # L0012912938 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010

(February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The request for hearing on decision # L0012912938 was due by October 6, 2025. Because claimant did not file their request for hearing until January 13, 2026, the request was late. On their response to the appellant questionnaire, claimant showed that they did not receive the administrative decision, and therefore were not aware of it until they spoke to a Department representative on January 12, 2026. EAB Exhibit 1 at 1. However, Department records suggest that claimant may have been notified of the decision via email or their Frances Online account, and that they might have, likewise, viewed the decision in Frances Online on September 16, 2025.¹

On remand, the ALJ should inquire, first, as to how decision # L0012912938 was sent to claimant, including mail, email, Frances Online, or by other means, as well as what communication preferences claimant elected when filing their claim with the Department. The ALJ should likewise inquire as to whether the decision was sent to claimant’s correct address or account by any of those means; if so, whether claimant was checking the relevant addresses or accounts around the time that decision # L0012912938 was sent to claimant; and, to the extent that the decision was sent to the wrong address or account, what caused such an error. To the extent that the record on remand shows that claimant viewed decision # L0012912938, either via email, their Frances Online account, or some other means prior to January 12, 2026, the ALJ should inquire as to when claimant did so, and what other factors, if any, caused their delay in filing the request for hearing.

Order No. 26-UI-323383 therefore is reversed, and this matter remanded for a hearing on whether claimant’s late request for hearing should be allowed and, if so, the merits of decision # L0012912938.

DECISION: Order No. 26-UI-323383 is set aside, and this matter remanded for further proceedings consistent with this order.
