

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0307**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On December 30, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 3, 2025 (decision # L0014898381).<sup>1</sup> On January 20, 2026, decision # L0014898381 became final without claimant having filed a request for hearing. On February 9, 2026, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 19, 2026 issued Order No. 26-UI-320703, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 5, 2026.

On March 3, 2026, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire and on March 23, 2026 issued Order No. 26-UI-324634, re-dismissing claimant's request for hearing as late without good cause and leaving decision # L0014898381 undisturbed. On March 30, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-324634's findings of fact, reasoning, and dismissal of claimant's late request for hearing as late without good cause and leaving decision # L0014898381 undisturbed. Order No. 26-UI-324634 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-324634 is affirmed.

<sup>1</sup> Decision # L0014898381 stated that claimant was denied benefits from August 3, 2025 to August 8, 2026. However, decision # L0014898381 should have stated that claimant was disqualified from receiving benefits beginning August 3, 2025 and until she earned four times her weekly benefit amount. See ORS 657.176.
