

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0313

Affirmed
No Disqualification

PROCEDURAL HISTORY: On February 18, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was disqualified from receiving benefits effective January 11, 2026 (decision # L0016151905).¹ Claimant filed a timely request for hearing. On March 11, 2026, ALJ Wahl conducted a hearing, and on March 13, 2026 issued Order No. 26-UI-323607, reversing decision # L0016151905 by concluding the claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On March 31, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider the employer's written argument because they did not state that they provided a copy of their argument to claimant as required by OAR 471-041-0080(2)(a) (May 13, 2019).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-323607's findings of fact, reasoning, and conclusion that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. Order No. 26-UI-323607 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-323607 is affirmed.

¹ Decision # L0016151905 stated that claimant was denied benefits from January 11, 2026 to January 9, 2027. However, decision # L0016151905 should have stated that claimant was disqualified from receiving benefits beginning January 11, 2026 and until he earned four times his weekly benefit amount. See ORS 657.176.
