

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0340

Affirmed
Disqualification

PROCEDURAL HISTORY: On September 29, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective August 17, 2025 (decision # L0013220434).¹ Claimant filed a timely request for hearing. On December 5, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 19, 2025. On December 19, 2025, claimant failed to appear at the hearing, and ALJ Bender issued Order No. 25-UI-314998, dismissing claimant's request for hearing due to her failure to appear. On December 23, 2025, claimant filed a timely request to reopen the hearing. On March 17, 2025, ALJ Bender conducted a hearing, and on March 25, 2026 issued Order No. 26-UI-325027 allowing claimant's request to reopen but affirming decision # L0013220434 on the merits. On April 8, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not state that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only the information received into evidence at the hearing. *See* ORS 657.275(2).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-325027's findings of fact, reasoning, and decision to allow claimant's request to reopen, and conclusion that the employer

discharged claimant for misconduct, disqualifying claimant from receiving benefits. Order No. 26-UI-325027 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-325027 is affirmed.
