

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0343**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On December 17, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation (decision # L0014754922). The employer filed a timely request for hearing. On March 24, 2026, ALJ Krueger conducted a hearing, and on March 26, 2026 issued Order No. 26-UI-325139, affirming decision # L0014754922. On April 9, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered employer's written argument when reaching this decision.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-325139's findings of fact, reasoning, and conclusion that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. Order No. 26-UI-325139 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-325139 is affirmed.
