

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0344

Affirmed
Late Request for Hearing Denied

PROCEDURAL HISTORY: On December 10, 2025, the Oregon Employment Department (the Department) served a notice of wages reported and possible claim (decision # L0014557714). On December 30, 2025, decision # L0014557714 became final without the employer having filed a request for hearing. On February 1, 2026, the employer filed a late request for hearing. ALJ Kangas considered the request, and on February 23, 2026 issued Order No. 26-UI-321102, dismissing the request late as late, subject to the employer's right to renew the request by responding to an appellant questionnaire by March 9, 2026. On March 16, 2026, Order No. 26-UI-321102 became final without the employer having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On March 18, 2026, the employer filed a late response to the appellant questionnaire. On March 23, 2026, ALJ Kangas issued Order No. 26-UI-324689, concluding that the employer's questionnaire response and would not be considered because it was late, re-dismissing the employer's request for hearing, and leaving decision # L0014557714 undisturbed. On April 10, 2026, the employer filed an application for review of Order No. 26-UI-324689 with EAB.

WRITTEN ARGUMENT: The employer did not state that they provided a copy of their argument to claimant as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from timely filing a response to the appellant questionnaire or otherwise offering the information into the hearing record as required by OAR 471-041-0090 (May 13, 2019). EAB considered only the information received into the hearing record. *See* ORS 657.275(2).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-324689's findings of fact, reasoning, and dismissal of the employer's late request for hearing, leaving decision # L0014557714 undisturbed. Order No. 26-UI-324689 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 26-UI-324689 is affirmed.
