

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0348

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 8, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant’s benefits would be reduced because of retirement pay beginning May 4, 2025 (decision # L0012259148). Claimant filed a timely request for hearing. On November 5, 2025, ALJ Christon conducted a hearing, and on November 7, 2025 issued Order No. 25-UI-309898, affirming decision # L0012259148. On December 1, 2025, Order No. 25-UI-309898 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 13, 2026, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 25-UI-309898, mailed to claimant on November 7, 2025, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 25-UI-309898 at 3. Order No. 25-UI-309898 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before December 1, 2025 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 25-UI-309898 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-309898 was due December 1, 2025. Because claimant did not file their application for review until April 13, 2026, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the December 1, 2025 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 13, 2026 is dismissed. Order No. 25-UI-309898 remains undisturbed.
