

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0349**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On May 3, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$4,742 in Pandemic Unemployment Assistance (PUA) benefits to which she was not entitled and was required to repay (decision # 125444). On May 23, 2022 decision # 125444 became final without claimant having filed a request for hearing.

On April 19, 2024 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 30, 2024 issued Order No. 24-UI-253185, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 14, 2024. On May 10, 2024, claimant filed a timely response to the appellant questionnaire. On May 16, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 24-UI-253185 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 125444.

On August 4, 2025, ALJ Christon conducted a hearing, and on August 8, 2025 issued Order No. 25-UI-300088, dismissing claimant's request for hearing as late without good cause and leaving decision # 125444 undisturbed. On August 28, 2025, Order No. 25-UI-300088 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 13, 2026, claimant filed a late application for review of Order No. 25-UI-300088 with EAB.

**FINDING OF FACT:** (1) Order No. 25-UI-300088, mailed to claimant on August 8, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-300088 at 4. Order No. 25-UI-300088 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 28, 2025 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 25-UI-300088 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-300088 was due August 28, 2025. Because claimant did not file her application for review until April 13, 2026, the application for review was late. Claimant’s application for review included a Notice of Determination for Pandemic Unemployment Assistance (PUA) dated February 19, 2021 and a handwritten note stating “Repayment due to what Emp dept determined I would get weekly. Confused please advise Thank you”. Although claimant’s application for review was filed almost eight months late, claimant did not include a written statement describing circumstances preventing her from filing the application for review by the August 28, 2025 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed. To the extent claimant is seeking information regarding her repayment, claimant may want to contact the Department directly.

**DECISION:** The application for review filed April 13, 2026 is dismissed. Order No. 25-UI-300088 remains undisturbed.
