

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0355**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On January 28, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective December 21, 2025 (decision # L0015768950).<sup>1</sup> Claimant filed a timely request for hearing. On March 26, 2026, ALJ Naylor conducted a hearing at which the employer failed to appear, and on March 30, 2026 issued Order No. 26-UI-325460, affirming decision # L0015768950. On April 16, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-325460's findings of fact, reasoning, and conclusion that claimant voluntarily quit work without good cause and is disqualified from receiving benefits effective December 21, 2025. Order No. 26-UI-325460 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-325460 is affirmed.

<sup>1</sup> Decision # L0015768950 stated that claimant was denied benefits from December 21, 2025 to December 19, 2026. However, decision # L0015768950 should have said that claimant was disqualified from receiving benefits beginning Sunday, December 21, 2025 and until he earned four times his weekly benefit amount. See ORS 657.176.
