

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0363

Affirmed
Ineligible Weeks 28-24 through 32-24

PROCEDURAL HISTORY: On January 9, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received remuneration that exceeded his weekly benefit amount for the week of July 7 through 13, 2024 (week 28-24) and was ineligible for benefits for that week (decision # L0015221920). Also on January 9, 2026, the Department served notice of an administrative decision concluding that claimant received remuneration that exceeded his weekly benefit amount for the week of July 14 through 20, 2024 (week 29-24) and was ineligible for benefits for that week (decision # L0015155618). Also on January 9, 2026, the Department serve notice of an administrative decision concluding that claimant received remuneration that exceeded his weekly benefit amount for the week of July 21 through 27, 2024 (week 30-24) and was ineligible for benefits for that week (decision # L0015093734). Also on January 9, 2026, the Department served notice of an administrative decision concluding that claimant received remuneration that exceeded his weekly benefit amount for the week of July 28 through August 3, 2024 (week 31-24) and was ineligible for benefits for that week (decision # L0015127508). Also on January 9, 2026, the Department served notice of an administrative decision concluding that claimant received remuneration that exceeded his weekly benefit amount for the week of August 4 through 10, 2024 (week 32-24) and was ineligible for benefits for that week (decision # L0015130727).

Claimant filed timely requests for hearing on decisions # L0015221920, L0015155618, L0015093734, L0015127508, and L0015130727. On March 23, 2026, ALJ Frank conducted a hearing on the decisions, and on March 31, 2026, issued Orders No. 26-UI-325603, 26-UI-325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620, affirming decisions # L0015221920, L0015155618, L0015093734, L0015127508, and L0015130727.

On April 16, 2026, claimant filed applications for review of Orders No. 26-UI-325603, 26-UI325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620 with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-325603, 26-UI-325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2026-EAB-0361, 2026-EAB-0363, 2026-EAB-0364, 2026-EAB-0360, and 2026-EAB-0362).

WRITTEN ARGUMENT: EAB considered claimant’s argument in reaching these decisions.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with the findings of fact, reasoning, and conclusions of Orders No. 26-UI-325603, 26-UI-325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620 that claimant received remuneration that exceeded his weekly benefit amount for the weeks at issue and was ineligible for benefits for those weeks. Orders No. 26-UI-325603, 26-UI-325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620 are **adopted**. *See* ORS 657.275(2).

DECISION: Orders No. 26-UI-325603, 26-UI-325605, 26-UI-325606, 26-UI-325611, and 26-UI-325620 are affirmed.
