

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0372

Affirmed
No Disqualification

PROCEDURAL HISTORY: On March 16, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective January 25, 2026 (decision # L0016476143).¹ Claimant filed a timely request for hearing. On April 15, 2026, ALJ Wahl conducted a hearing, and on April 16, 2026 issued Order No. 26-UI-327424, reversing decision # L0016476143 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits based on the quit. On April 20, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-327424's findings of fact, reasoning, and conclusion that claimant quit work with good cause and was not disqualified from receiving benefits. Order No. 26-UI-327424 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-327424 is affirmed.

¹ Decision # L0016476143 stated that claimant was denied benefits from January 25, 2026 to January 30, 2027. However, decision # L0016476143 should have stated that claimant was disqualified from receiving benefits beginning January 25, 2026 and until he earned four times his weekly benefit amount. See ORS 657.176.
