

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0379

Affirmed
Late Requests for Hearing Allowed
Ineligible Week 39-25 & Eligible Week 8-26

PROCEDURAL HISTORY: On September 9, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not confirm her identity as required and therefore was not eligible for benefits beginning August 31, 2025 (decision # L0012769047). On September 16, 2025, the Department served notice of an administrative decision concluding that claimant did not complete her registration for work requirements and therefore was not eligible for benefits beginning August 31, 2025 (decision # L0013209267). On September 29, 2025 and October 6, 2025, respectively, decisions # L0012769047 and L0013209267 became final without claimant having filed requests for hearing. On October 27, 2025, claimant filed late requests for hearing on decisions # L0012769047 and L0013209267.

ALJ Kangas considered claimant's requests, and on November 25, 2025 issued Orders No. 25-UI-312199 and 25-UI-312202, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by December 9, 2025. On December 9, 2025, claimant filed timely responses to the appellant questionnaires. On February 25, 2026, OAH served notice of a hearing scheduled for March 11, 2026 on whether to allow claimant's late requests for hearing and, if so, the merits of decisions # L0012769047 and L0013209267.

On March 11, 2026, ALJ Janzen conducted a hearing, and on March 12, 2026 issued Orders No. 26-UI-323460 and 26-UI-323459, allowing claimant's late requests for hearing and modifying decisions # L0012769047 and L0013209267 by concluding that claimant was not eligible for benefits for the week of September 21 through 27, 2025 (week 39-25), but was eligible for benefits for the week of February 22 through 28, 2026 (week 8-26).

On April 1, 2026, claimant filed applications for review of Orders No. 26-UI-323460 and 26-UI-323459 with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-323460 and 26-UI-323459 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2026-EAB-0378 and 2026-EAB-0379).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-323460 and 26-UI-323459's findings of fact, reasoning, and decisions to allow claimant's late requests for hearing and modify decisions # L0012769047 and L0013209267 by concluding that claimant was not eligible for benefits for week 39-25 but was eligible for benefits week 8-26. Orders No. 26-UI-323460 and 26-UI-323459 are **adopted**. See ORS 657.275(2).

DECISION: Orders No. 26-UI-323460 and 26-UI-323459 are affirmed.
