

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0380**

*Late Applications for Review Dismissed Without Prejudice*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On December 16, 2025, the Oregon Employment Department (the Department) served notice of administrative decisions concluding claimant filed late claims for the weeks of August 3 to 9, 2025, August 10 to 16, 2025, August 17 to 23, 2025, September 28 to October 4, 2025, October 5 to 11, 2025, October 12 to 18, 2025, October 19 to 25, 2025, October 26 to November 1, 2025, and November 16 to 22, 2025, and was denied benefits for those weeks (decisions # L0014747304, L0014861631, L0014650539, L0014770715, L0014887463, L0014778915, L0014912658, L0014890992, and L0014907113 respectively). On January 5, 2026, claimant filed timely requests for a hearing. On March 16, 2026, ALJ Frank conducted a hearing, and on March 24, 2026 issued Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824 affirming the administrative decisions.

On April 13, 2026, Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On April 22, 2026, claimant filed late applications for review with EAB.

EAB combined its review of Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in nonuplicate (EAB Decisions 2026-EAB-0387, 2026-EAB-0385, 2026-EAB-0384, 2026-EAB-0383, 2026-EAB-0388, 2026-EAB-0381, 2026-EAB-0386, 2026-EAB-0382, and 2026-EAB-0380).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement included with her applications for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must send the objection to EAB in writing, explaining why they object, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** Claimant’s applications for review are dismissed without prejudice.

On April 22, 2026, claimant filed applications for review of Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 13, 2026. Claimant’s applications for review are therefore late, and the applications for review are dismissed.

The deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes they have good cause and filed their late applications for review within a reasonable time, claimant may ask EAB to *reconsider* this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all four** of the following:

1. Claimant must file the request for reconsideration by June 3, 2026, *and*
2. Claimant must provide more specific details about the reason they filed *late* applications for review. For example, claimant should include specific information about the date she received the ALJ’s Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824, whether she read and disagreed with the orders, and how she was prevented from filing her applications for review by the April 13, 2026 deadline date. Claimant should include specific details that might help EAB decide whether or not claimant had “good cause,” which means factors or circumstances beyond her reasonable control prevented her from filing timely applications for review, *and*
3. Claimant must provide the date the circumstances that prevented her from filing timely applications for review ended (the circumstances they listed in response to #3, above), *and*
4. Claimant must provide sufficient information to prove that she filed her applications for review within **seven** days of the date the circumstances that prevented her from filing timely applications for review ended.

There are several ways to file a request for reconsideration:

**DECISION:** The applications for review filed April 22, 2026 are dismissed without prejudice. Orders No. 26-UI-324800, 26-UI-324804, 26-UI-324805, 26-UI-324806, 26-UI-324808, 26-UI-324809, 26-UI-324816, 26-UI-324818, and 26-UI-324824 remain undisturbed.

Claimant should provide any information regarding the dates her mother was hospitalized and how that impacted her ability to file the applications for review by the April 13, 2026 deadline and what prompted her to file the applications for review on April 22, 2026 instead.

Claimant should provide any other details which may assist EAB in determining whether claimant had good cause for filing the applications for review late and filed within a reasonable time after those circumstances ended.
