

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0417

Affirmed
Ineligible for Benefits Weeks 20-25, 1-26 & 2-26

PROCEDURAL HISTORY: On May 6, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant benefits beginning April 27, 2025 because claimant failed to confirm his identity as required by the Department (decision # L0010564059). On May 27, 2025, decision # L0010564059 became final without claimant having filed a request for hearing. On January 28, 2026, claimant filed a late request for hearing. On April 3, 2026, ALJ Parnell conducted a hearing, and on April 9, 2026 issued Order No. 26-UI-326566, allowing claimant's late request for hearing and modifying decision # L0010564059 by concluding that claimant failed to confirm his identity and was not eligible for benefits for the weeks of May 11 to 17, 2025 and January 4 through 17, 2026. On April 29, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-326566's findings of fact, reasoning, decision to allow claimant's late request for hearing, and modification of decision # L0010564059 by concluding that claimant failed to confirm his identity as required by the Department and was not eligible for benefits for the weeks of May 11 to 17, 2025 and January 4 through 17, 2026 (weeks 20-25 and 1 through 2-26. Order No. 26-UI-326566 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-326566 is affirmed.
