

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0422

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 19, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective October 19, 2025 (decision # L0016136977). Claimant filed a timely request for hearing. On March 18, 2026, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 1, 2026. On April 1, 2026, claimant failed to appear at the hearing, and ALJ Franco issued Order No. 26-UI-325751, dismissing claimant's request for hearing due to their failure to appear. On April 10, 2026, claimant filed a timely request to reopen the hearing. ALJ Scott considered claimant's request, and on April 22, 2026, issued Order No. 26-UI-327884, denying the request and leaving Order No. 26-UI-325751 undisturbed. On April 30, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not state that they provided a copy of their argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the record and did not show that factors or circumstances beyond claimant's reasonable control prevented claimant from offering the information with their request to reopen the hearing as required by OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including any witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-327884's findings of fact, reasoning, and denial of claimant's request to reopen, leaving Order No. 26-UI-325751, which dismissed claimant's request for hearing on decision # L0016136977, undisturbed. Order No. 26-UI-327884 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-327884 is affirmed.
