

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0427**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On January 29, 2024, the Oregon Employment Department (the Department) served notice of an amended determination for pandemic unemployment assistance (PUA) concluding that claimant was not entitled to PUA benefits (amended PUA determination). On January 31, 2024 the department served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain \$36,664 in benefits to which they were not entitled and must repay, and assessing a \$5,499.60 monetary penalty (overpayment decision).

Claimant filed a timely request for hearing on the amended PUA determination and overpayment decision. On March 5, 2024 the office of administrative hearings (OAH) served notice of a hearing scheduled for March 19, 2024. On March 19, 2024 claimant failed to appear at the hearing, and ALJ Janzen issued Orders No. 24-UI-250410 and 24-UI-250411, dismissing claimant's request for hearing due to his failure to appear, leaving the amended PUA determination and overpayment decision undisturbed. On April 8, 2024, Orders No. 24-UI-250410 and 24-UI-250411 became final without claimant having filed a request to reopen the March 19, 2024 hearing.

On April 26, 2026, claimant filed a late request to reopen the March 19, 2024 hearing. ALJ Scott considered the request and on April 28, 2026 issued Orders No. 26-UI-328531 and 26-UI-328529, denying the request to reopen and leaving Orders No. 24-UI-250410 and 24-UI-250411 undisturbed. On May 4, 2026 claimant filed timely applications for review of Orders No. 26-UI-328531 and 26-UI-328529 with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 26-UI-328531 and 26-UI-328529 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2026-EAB-0427 and 2026-EAB-0428).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-328531's and 26-UI-328529's findings of fact, reasoning, and denial of claimant's late request to reopen the March 19, 2024 hearing. Orders No. 26-UI-328531 and 26-UI-328529 are **adopted**. See ORS 657.275(2).

**DECISION:** Orders No. 26-UI-328531 and 26-UI-328529 are affirmed.
