

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0429

Affirmed
Disqualification

PROCEDURAL HISTORY: On March 19, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer, but not for misconduct, and not disqualified from receiving benefits based on the discharge (decision # L0016530685). The employer filed a timely request for hearing. On April 1, 2026, notice was mailed to the parties that a hearing was scheduled for April 15, 2026. On April 15, 2026, ALJ Franco conducted a hearing at which claimant failed to appear, and on April 23, 2026 issued Order No. 26-UI-328067, reversing decision # L0016530685 by concluding that claimant was discharged for misconduct and disqualified from receiving benefits effective September 28, 2025. On April 27, 2026, claimant filed an application for review of Order No. 26-UI-328067 that was treated by the Office of Administrative Hearings (OAH) as a timely request to reopen the April 15, 2026 hearing. ALJ Kangas considered the request to reopen, and on May 5, 2026 issued Order No. 26-UI-329386, denying the request, subject to claimant’s right to renew the request by providing information about why she failed to appear at the hearing by May 19, 2026. On May 26, 2026, Order No. 26-UI-329386 became final without claimant having provided additional information in support of her request to reopen, or an application for review of that order. This matter comes before the Employment Appeals Board (EAB) based upon claimant’s April 27, 2026 application for review of Order No. 26-UI-328067.¹

¹ OAR 471-040-0040(6) (February 10, 2012) provides, “The OAH will treat as a request to reopen the hearing any application for review that a party files with the Employment Appeals Board or the Employment Department, where the filing party failed to appear at the hearing that led to the decision on appeal, unless the applicant specifically states in the application that the applicant does not wish to have the case reopened. In the event that the OAH subsequently denies the request to reopen the hearing, it shall return the case to the Employment Appeals Board, which will then proceed to review the merits of the substantive decision. The original application for review shall serve as the basis for the Employment Appeals Board’s review of the merits of that decision.” However, OAR 471-041-0060(5)(b) (May 13, 2019) provides, “An application for review filed by a claimant or employer that failed to appear at the hearing and whose request for hearing was not dismissed for failure to appear will be treated as an application for review if. . . [t]he application for review does not include a written statement that sets forth the reason(s) for missing the hearing as required under OAR 471-040-0040(3).” Claimant’s application for review of Order No. 26-UI-328067 did not contain an explanation for having missed the April 15, 2026 hearing. *See* Exhibit 5 at 1. Nevertheless, the combined effect of these rules is that claimant is entitled to EAB review of Order No. 26-UI-328067, which concerns the merits of the work separation.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-328067’s findings of fact, reasoning, and conclusion that claimant was discharged for misconduct. Order No. 26-UI-328067 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 26-UI-328067 is affirmed.
