

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0458**

*Application for Review Dismissed*  
*No Justiciable Controversy*  
*Eligible Weeks 2-26 through 4-26*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On February 26, 2026, the Oregon Employment Department (the Department) served notice of administrative decisions concluding that claimant filed late claims for benefits for the weeks of January 11 to January 17, 2026; January 18 to January 24, 2026; and January 25 to January 31, 2026 and therefore claimant was denied unemployment insurance benefits for those weeks (decisions # L0016193898, L0016206182, and L0016234342 respectively). Claimant filed timely requests for hearing.

On April 14, 2026, ALJ S. Lee conducted a combined hearing, and on April 23, 2026 issued Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167, reversing decisions # L0016193898, L0016206182, and L0016234342, respectively, by concluding that claimant's claims should be treated as timely filed and that claimant is entitled to benefits for the weeks of January 11 to January 17, 2026; January 18 to January 24, 2026; and January 25 through January 31, 2026, if otherwise eligible.

On May 7, 2026, claimant filed applications for review with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2026-EAB-0457, 2026-EAB- 0452, and 2026-EAB-0458).

**CONCLUSIONS AND REASONS:** Claimant's applications for review of Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 present no justiciable controversy and are dismissed.

On May 7, 2026, claimant filed with EAB several applications for review, including applications for review of Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167. Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 were fully favorable to claimant because they found that claimant's claim for each week at issue (weeks 2-26 through 4-26) should be treated as timely filed and that claimant is entitled to benefits for those weeks (January 11 to January 31, 2026, collectively) if otherwise eligible. Oregon courts follow the principle that a review on appeal may only be provided for justiciable controversies. *See, e.g., Gortmaker v. Seaton*, 252 Or. 440, 442, 450 P.2d 547 (1969). A justiciable

controversy exists when the interests of the parties to the action conflict with each other, and the appeal will have some practical effect on the rights of the parties to the controversy. *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). To show a practical effect on their rights, an appellant must seek “substantive relief” through their appeal. *Krisor v. Henry*, 256 Or. App. 56, 300 P.3d 199 (Or. Ct. App. 2013).

Claimant did not assign error to any portion of Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167, did not request reversal of any portion of the orders, and alleged no facts entitling claimant to further relief in this matter. Because all the orders under review granted claimant benefits for the weeks at issue, EAB’s review could not provide further substantive relief to claimant, and such review would have no practical effect on claimant’s rights. Accordingly, there is no justiciable controversy before EAB based upon claimant’s applications for review. Because the cases before EAB present no justiciable controversy, the applications for review of Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 are dismissed. Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 remain undisturbed.

**DECISION:** The applications for review filed May 7, 2026 are dismissed. Orders No. 26-UI-328164, 26-UI-328166, and 26-UI-328167 remain undisturbed.
