

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0464**

*Application for Review Dismissed*  
*No Justiciable Controversy*  
*Eligible Weeks 38-25 and 4-26*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On February 20, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work and was denied benefits for the week of September 14 to 20, 2025 (decision # L0016186713). On February 26, 2026, the Department service notice of an administrative decision concluding that claimant failed to actively seek work and was denied benefits for the week of January 25 to 31, 2026 (decision # L0016439520). Claimant filed timely requests for hearing.

On April 13, 2026, ALJ S. Lee conducted a combined hearing. On April 22, 2026, ALJ Lee issued Order No. 26-UI-328035, reversing decision # L0016186713 by concluding that claimant was actively seeking work and eligible for benefits for the week of September 14 to 20, 2025. On April 23, 2026, ALJ Lee issued Order No. 26-UI-328158, reversing decision # L0016439520 by concluding that claimant was actively seeking work and eligible for benefits for the week of January 25 to 31, 2026.

On May 7, 2026, claimant filed applications for review with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-328035 and 26-UI-328158 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2026-EAB-0466 and 2026-EAB-0464).

**CONCLUSIONS AND REASONS:** Claimant's applications for review of Orders No. 26-UI-328035 and 26-UI-328158 present no justiciable controversy and are dismissed.

On May 7, 2026, claimant filed with EAB several applications for review, including applications for review of Orders No. 26-UI-328035 and 26-UI-328158. Orders No. 26-UI-328035 and 26-UI-328158 are fully favorable to claimant because they grant claimant benefits for the weeks at issue (September 14 to 20, 2025 and January 25 to 31, 2026). Oregon courts follow the principle that a review on appeal may only be provided for justiciable controversies. *See, e.g., Gortmaker v. Seaton*, 252 Or. 440, 442, 450 P.2d 547 (1969). A justiciable controversy exists when the interests of the parties to the action conflict with each other, and the appeal will have some practical effect on the rights of the parties to the

controversy. *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). To show a practical effect on their rights, an appellant must seek “substantive relief” through their appeal. *Krisor v. Henry*, 256 Or. App. 56, 300 P.3d 199 (Or. Ct. App. 2013).

Claimant did not assign error to any portion of Orders No. 26-UI-328035 or 26-UI-328158, did not request reversal of any portion of the orders, and alleged no facts entitling claimant to further relief in this matter. Because both orders under review granted claimant benefits for the weeks at issue, EAB’s review could not provide further substantive relief to claimant, and such review would have no practical effect on the claimant’s rights. Accordingly, there is no justiciable controversy before EAB based upon claimant’s applications for review. Because the cases before EAB present no justiciable controversy, the applications for review of Orders No. 26-UI-328035 and 26-UI-328158 are dismissed. Orders No. 26-UI-328035 and 26-UI-328158 remain undisturbed.

**DECISION:** The applications for review filed May 7, 2026 are dismissed. Orders No. 26-UI-328035 and 26-UI-328158 remain undisturbed.
