

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0485**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On July 22, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant failed to confirm their identity and denying benefits beginning July 13, 2025 (decision # L0011973052). On August 11, 2025, decision # L0011973052 became final without claimant having filed a request for hearing. On January 21, 2026, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 11, 2026 issued Order No. 26-UI-323221, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 25, 2026.

On March 31, 2026, Order No. 26-UI-323221 became final without claimant having filed a timely response to the appellant questionnaire or a timely application for review of Order No. 26-UI-323221 with the Employment Appeals Board (EAB). On April 3, 2026 claimant filed a late response to the appellant questionnaire. On April 23, 2026, ALJ Scott issued Order No. 26-UI-328112, concluding that claimant's questionnaire response was late and would not be considered, and entering a final order dismissing claimant's late request for hearing on decision # L0011973052. On May 8, 2026, claimant filed an application for review of Order No. 26-UI-328112 with EAB.

**WRITTEN ARGUMENT:** Claimant submitted a written argument with their application for review that contained new information about why their request for hearing was late. However, the argument did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record before the ALJ at OAH by timely responding to the appellant questionnaire. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB did not consider claimant's new information.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-328112's findings of fact, reasoning, and dismissal of claimant's late request for hearing on decision # L0011973052. Order No. 26-UI-328112 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-328112 is affirmed.
