

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0488

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 25, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late report for benefits for the week of February 8 through 14, 2026 (week 06-26) and was ineligible for benefits for that week (decision # L0016157231). On March 17, 2026, decision # L0016157231 became final without claimant having filed a request for hearing. On April 5, 2026, claimant filed a late request for hearing on decision # L0016157231. On April 28, 2026, ALJ Frank conducted a hearing,¹ and on May 5, 2026 issued Order No. 26-UI-329331, dismissing claimant's request for hearing as late without good cause and leaving decision # L0016157231 undisturbed. On May 8, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted a written argument which addressed both the late request for hearing issue in this matter and the merits of the other ten cases consolidated at hearing. EAB did not consider any portions of claimant's argument relating solely to the merits of the other ten late-report cases because those portions were not relevant and material to EAB's determination of whether claimant's late request for hearing on decision # L0016157231 should be allowed. ORS 657.275(2) and OAR 471-041-0090(1)(b)(A) (May 13, 2019). EAB considered the portions of claimant's written argument that were relevant to the late request for hearing issue.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-329331's findings of fact, reasoning, and dismissal of claimant's late request for hearing. Order No. 26-UI-329331 is **adopted**. See ORS 657.275(2).

¹ The hearing on claimant's late request for hearing on decision # L0016157231 was consolidated with ten other cases, UI Cases No. 2026-UI-56997, 2026-UI-56998, 2026-UI-56999, 2026-UI-57000, 2026-UI-57001, 2026-UI-57003, 2026-UI-57004, 2026-UI-57005, 2026-UI-57006, and 2026-UI-57007. Those cases, also involving late claims for benefits, were heard on the merits, and claimant subsequently filed applications for review of the orders issued on the merits of those cases. EAB will issue decisions on the merits of those cases under separate cover.

DECISION: Order No. 26-UI-329331 is affirmed.
