

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0495

Affirmed
Ineligible Weeks 47-25 through 3-26

PROCEDURAL HISTORY: On March 27, 2026, the Oregon Employment Department (the Department) served notice of administrative decisions concluding that claimant filed late claims for the weeks of November 16 to November 22, 2025; November 23 to November 29, 2025; November 30 to December 6, 2025; December 7 to December 13, 2025; December 14 to December 20, 2025; December 21 to December 27, 2025; December 28, 2025 to January 3, 2026; January 4 to January 10, 2026; January 11 to January 17, 2026; and January 18 to January 24, 2026 and was not eligible for benefits for those weeks (decisions # L0016714741, L0016781811, L0016805360, L0016769193, L0016768427, L0016748258, L0016660687, L0016786773, L0016729322, and L0016725801 respectively). Claimant filed timely requests for hearing.

On April 28, 2026, ALJ Frank conducted a combined hearing, and on May 5, 2026 issued Orders No. 26-UI-329290, 26-UI-329291, 26-UI-329295, 26-UI-329300, 26-UI-329301, 26-UI-329303, 26-UI-329306, 26-UI-329309, 26-UI-329310, and 26-UI-329312 affirming the above listed administrative decisions.

On May 8, 2026, claimant filed applications for review with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-329290, 26-UI-329291, 26-UI-329295, 26-UI-329300, 26-UI-329301, 26-UI-329303, 26-UI-329306, 26-UI-329309, 26-UI-329310, and 26-UI-329312 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in tentuplicate (EAB Decisions 2026-EAB-0495, 2026-EAB-0498, 2026-EAB-0491, 2026-EAB-0492, 2026-EAB-0493, 2026-EAB-0494, 2026-EAB-0489, 2026-EAB-0497, 2026-EAB-0496, and 2026-EAB-0490).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. The argument also contained information that was not relevant and material to EAB's determination of whether claimant claimed the weeks at issue late. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information

received into evidence at the hearing. EAB considered any parts of claimant's argument that were relevant, material, and based on the hearing record.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-329290, 26-UI-329291, 26-UI-329295, 26-UI-329300, 26-UI-329301, 26-UI-329303, 26-UI-329306, 26-UI-329309, 26-UI-329310, and 26-UI-329312's findings of fact, reasoning, and conclusion that claimant filed late claims for the weeks of November 16, 2025 through January 24, 2026 (weeks 47-25 through 3-26) and was not eligible for benefits for those weeks. Orders Nos. 26-UI-329290, 26-UI-329291, 26-UI-329295, 26-UI-329300, 26-UI-329301, 26-UI-329303, 26-UI-329306, 26-UI-329309, 26-UI-329310, and 26-UI-329312 are **adopted**. See ORS 657.275(2).

DECISION: Orders No. 26-UI-329290, 26-UI-329291, 26-UI-329295, 26-UI-329300, 26-UI-329301, 26-UI-329303, 26-UI-329306, 26-UI-329309, 26-UI-329310, and 26-UI-329312 are affirmed.
