

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0519

Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On December 9, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to complete a Reemployment Services and Eligibility Assessment (RESEA) interview and was denied benefits beginning November 16, 2025 (decision # L0014659124). On December 29, 2025, decision # L0014659124 became final without claimant having filed a request for hearing. On February 3, 2026, the Department served notice of an administrative decision concluding that claimant failed to confirm their identity as required and was denied benefits beginning February 2, 2026 (decision # L0015825042). On February 23, 2026 decision # L0015825042 became final without claimant having filed a request for hearing.

On March 11, 2026, claimant filed a late request for hearing on decision # L0015825042. On March 23, 2026, claimant filed a late request for hearing on decision # L0014659124. ALJ Kangas considered the requests, and on March 18, 2026 and April 16, 2026 issued Orders No. 26-UI-324224 and 26-UI-327296, dismissing the requests as late, subject to claimant's right to renew the requests by April 1, 2026 and April 30, 2026, respectively. On May 1, 2026, claimant filed late responses to the appellant questionnaires with the Office of Administrative Hearings (OAH). On May 7, 2026, ALJ Kangas issued Orders No. 26-UI-329616 and 26-UI-329617, re-dismissing claimant's requests for hearing as late without good cause, leaving decisions # L0014659124 and L0015825042 undisturbed.

On May 19, 2026, claimant filed applications for review of Orders No. 26-UI-329616 and 26-UI-329617 with the Employment Appeals Board (EAB). EAB combined its review of Orders No. 26-UI-329616 and 26-UI-329617 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2026-EAB-0520 and 2026-EAB-0519).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-329616's and 26-UI-329617's findings of fact, reasoning, and dismissal of claimant's requests for hearing as late without good cause,

leaving decisions # L0014659124 and L0015825042 undisturbed. Orders No. 26-UI-329616 and 26-UI-329617 are **adopted**. See ORS 657.275(2).

DECISION: Orders No. 26-UI-329616 and 26-UI-329617 are affirmed.
