

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0522

Affirmed
Disqualification

PROCEDURAL HISTORY: On March 24, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving benefits from February 15, 2026 to February 13, 2027 (decision # L0016744537). Claimant filed a timely request for hearing. On May 5, 2026, ALJ Naylor conducted a hearing, and on May 6, 2026 issued Order No. 26-UI-329431, modifying decision # L0016744537 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective January 4, 2026 and until requalified by the Department.¹ On May 20, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including all witness testimony. EAB agrees with Order No. 26-UI-329431's findings of fact, reasoning, and conclusion that claimant quit work without good cause and was disqualified from receiving benefits based on the work separation effective January 4, 2026. Order No. 26-UI-329431 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-329431 is affirmed.

¹ Although Order No. 26-UI-329431 said it affirmed decision # L0016744537, it modified that decision by changing the beginning date of the disqualification from February 15, 2026 to January 4, 2026 and by changing the ending date of the disqualification from February 13, 2027 to until claimant is requalified by the Department. Order No. 26-UI-329431 at 2.
