

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0524**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On January 28, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work and therefore was not eligible for benefits beginning January 12, 2025 (decision # L0008973222). On February 18, 2025, decision # L0008973222 became final without claimant having filed a request for hearing. On November 25, 2025, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 11, 2025 issued Order No. 25-UI-313852, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 25, 2025.

On December 31, 2025, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH). On February 26, 2026, ALJ Scott issued Order No. 26-UI-321692, concluding that the appellant questionnaire response was late and would not be considered, and dismissing the late request for hearing on decision # L0008973222. On March 18, 2026, Order No. 26-UI-321692 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 19, 2026, claimant filed a late application for review of Order No. 26-UI-321692.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of an email from OAH to claimant dated March 18, 2026 and claimant's response back to OAH dated March 19, 2026. The emails have been marked as EAB Exhibit 1 and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, reading why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 26-UI-321692, mailed to claimant on February 26, 2026, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 26-UI-321692 at 2. Order No. 26-UI-321692 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 18, 2026 to be timely."

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 26-UI-321692 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-321692 was due March 18, 2026. Because claimant did not file their application for review until March 19, 2026, the application for review was late.

On March 18, 2026, OAH sent an emailed copy of the order to claimant stating, “An administrative decision mailed to you. Unfortunately, it was undelivered. Please see the attached final order for your case.” EAB Exhibit 1 at 1. Claimant responded to the March 18, 2026 email from OAH on March 19, 2026. In pertinent part, claimant stated “I did move I am now living at [new address]. EAB Exhibit 1 at 1. Claimant’s response indicates that he did not receive a copy of Order No. 26-UI-321692 because he had moved while his appeal was pending and did not update his address with OAH. Under OAR 471-040-0010(1)(b)(A). “Good cause” does not include failure to receive a document due to not notifying the Department or OAH of an updated address if the person knows, or reasonably should know, of a pending appeal. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed May 19, 2026 is dismissed. Order No. 26-UI-321692 remains undisturbed.
