

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0536**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On April 21, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits from February 22, 2026 to July 11, 2026 (decision # L0017129422). Claimant filed a timely request for hearing. On May 8, 2026, ALJ Franco conducted a hearing, and on May 21, 2026 issued Order No. 26-UI-330885, modifying decision # L0017129422 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective February 22, 2026 and until requalified by the Department. On May 26, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument because she did not state that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-330885's findings of fact, reasoning, and conclusion that claimant quit work without good cause and was disqualified from receiving benefits effective February 22, 2026.<sup>1</sup> Order No. 26-UI-330885 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-330885 is affirmed.

<sup>1</sup> Order No. 26-UI-330885's Conclusion of Law states "The claimant voluntarily quit work with good cause." This is presumed to be a scrivener's error and should have read "The claimant voluntarily quit work without good cause" as the order concluded that claimant voluntarily quit without good cause and the analysis supports that conclusion. Order No. 26-UI-330885 at 2, 4.
