

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0537

Affirmed
Ineligible Weeks 12-26 through 15-26

PROCEDURAL HISTORY: On March 31, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm his identity as required by the Department and therefore was not eligible for unemployment insurance benefits beginning March 22, 2026 (decision # L0016836519). Claimant filed a timely request for hearing. On May 14, 2026, ALJ Adamson conducted a hearing at which the Department failed to appear and issued Order No. 26-UI-330265, modifying decision # L0016836519 by concluding that claimant failed to confirm his identity and was not eligible for benefits from March 22, 2026 through April 18, 2026 (weeks 12-26 through 15-26).¹ On May 26, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-330265's findings of fact, reasoning, and conclusion that claimant failed to confirm his identity as required by the Department and was not eligible for benefits from March 22, 2026 through April 18, 2026 (weeks 12-26 through 15-26). Order No. 26-UI-330265 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-330265 is affirmed.
