

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0541**

*Affirmed*  
*Ineligible Weeks 2-26 through 6-26*

**PROCEDURAL HISTORY:** On March 3, 2026, the Oregon Employment Department (the Department) served notice of administrative decisions concluding that claimant filed late claims for benefits for the weeks from January 11 through February 14, 2026 and was denied benefits for those weeks (decisions # L0016274065, L0016324502, L0016319620, L0016345848, and L0016356812 respectively). Claimant filed a timely request for hearing on the decisions. On May 13, 2026, ALJ Micheletti conducted a combined hearing, and on May 14, 2026 issued Orders No. 26-UI-330299, 26-UI-330297, 26-UI-330304, 26-UI-330301, and 26-UI-330305, affirming decisions # L0016274065, L0016324502, L0016319620, L0016345848, and L0016356812 respectively. On May 26, 2026, claimant filed applications for review of the ALJ's orders with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 26-UI-330299, 26-UI-330297, 26-UI-330304, 26-UI-330301, and 26-UI-330305 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in quintuplicate (EAB Decisions 2026-EAB-0542, 2026-EAB-0538, 2026-EAB-0540, 2026-EAB-0541, and 2026-EAB-0539).

**WRITTEN ARGUMENT:** EAB considered claimant's argument in reaching this decision.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-330299, 26-UI-330297, 26-UI-330304, 26-UI-330301, 26-UI-330305's findings of fact, reasoning, and conclusion that claimant was not eligible for benefits for the weeks of January 11 through February 14, 2026 (weeks 2-26 through 6-26) because she filed her weekly claims late. Orders No. 26-UI-330299, 26-UI-330297, 26-UI-330304, 26-UI-330301, and 26-UI-330305 are **adopted**. See ORS 657.275(2).

**DECISION:** Orders No. 26-UI-330299, 26-UI-330297, 26-UI-330304, 26-UI-330301, and 26-UI-330305 are affirmed.
