

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0543**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On March 30, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving unemployment insurance benefits effective January 25, 2026 (decision # L0016741219).<sup>1</sup> Claimant filed a timely request for hearing. On April 22, 2026, ALJ Nyberg conducted a hearing, and on May 1, 2026 issued Order No. 26-UI-329004, reversing decision # L0016741219 by concluding that claimant was discharged, but not for misconduct, and therefore was not disqualified from receiving benefits based on the work separation. On May 21, 2026, Order No. 26-UI-329004 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On May 22, 2026, the employer filed a late application for review of Order No. 26-UI-329004 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the employer's written statement enclosed with the application for review, which has been marked as EAB Exhibit 1 and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 26-UI-329004, mailed to the employer on May 1, 2026,<sup>2</sup> stated, "You may appeal this decision by filing the attached form Application for Review with the Employment

<sup>1</sup> Decision # L0016741219 stated that claimant was denied benefits from January 25, 2026 to December 26, 2026. However, decision # L0016741219 should have said that claimant was disqualified from receiving benefits beginning Sunday, January 25, 2026 and until she earned four times her weekly benefit amount. *See* ORS 657.176.

<sup>2</sup> The employer wrote in their statement that they were writing regarding a hearing decision "dated May 5, 2026." EAB Exhibit 1 at 1. However, the order under review was issued on May 1, 2026, and a review of OAH records does not show that any other order was issued in this matter on May 5, 2026 or any other date. EAB has taken notice of this fact, which is contained in Employment Department records. OAR 471-041-0090(1). Any party that objects to EAB taking notice of this

Appeals Board within 20 days of the date that this decision is mailed.” Order No. 26-UI-329004 at 3. Order No. 26-UI-329004 also said on its Certificate of Mailing, “Any appeal from this Order must be filed on or before May 21, 2026 to be timely.”

**CONCLUSIONS AND REASONS:** The employer’s late application for review of Order No. 26-UI-329004 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-329004 was due by May 21, 2026. Because the employer did not file their application for review until May 22, 2026, the application for review was late.<sup>3</sup> The employer provided a written statement with the application for review. However, the employer’s written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and the employer’s late application for review is dismissed.

**DECISION:** The application for review filed May 22, 2026 is dismissed. Order No. 26-UI-329004 remains undisturbed.

<sup>3</sup> The filing date for an application for review filed by mail is the postmark date on the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). Where the information specified in OAR 471-041-0065(1) is missing, unclear, or improbable, the filing date is the date that EAB finds to be the most probable date of filing. OAR 471-041-0065(2). The employer filed their application for review by mail, but the postmark on the envelope in which it was mailed is illegible. EAB Exhibit 1 at 2. Therefore, May 22, 2026, the printed date on the application for review, is considered the most probable date of filing. EAB Exhibit 1 at 1.
