

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0553

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 30, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm their identity as required and was not eligible for benefits beginning September 21, 2025 (decision # L0013189273). On October 20, 2025, decision # L0013189273 became final without claimant having filed a request for hearing.

On April 7, 2026, claimant filed a late request for hearing. ALJ Scott considered claimant's request, and on May 4, 2026 issued Order No. 26-UI-329177, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 18, 2026. On May 26, 2026, Order No. 26-UI-329177 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 28, 2026, claimant filed a late application for review of Order No. 26-UI-329177 with EAB.

FINDING OF FACT: (1) Order No. 26-UI-329177, mailed to claimant on May 4, 2026, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 26-UI-329177 at 2. Order No. 26-UI-329177 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 26, 2026."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 26-UI-329177 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-329177 was due May 26, 2026. Because claimant did not file their application for review until May 28, 2026, the application for review was late. Although claimant's application for review included a partial response to the appellant questionnaire, claimant did not include a written statement describing circumstances Preventing claimant from filing the application for review by the May 26, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 28, 2026 is dismissed. Order No. 26-UI-329177 remains undisturbed.
