

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0556**

*Affirmed*

*Ineligible Weeks 41-25 through 42-25; 44-25 through 49-25, & 52-25 through 53-25*

**PROCEDURAL HISTORY:** On March 25, 2026, the Oregon Employment Department (the Department) served notice of ten administrative decisions concluding that claimant filed late claims for benefits for each of the weeks of October 5 to October 18, 2025; October 26 to December 6, 2025; and December 21, 2025 to January 3, 2026 (weeks 41-25 through 42-25; 44-25 through 49-25, 52-25, and 53-25) and therefore was denied benefits for those weeks (decisions # L0016741698, L0016693869, L0016749080, L0016774760, L0016747889, L0016830212, L0016757570, L0016709946, L0016704361, and L0016760350, respectively). Claimant filed timely requests for hearing on all ten administrative decisions.

On May 13, 2026, ALJ Nyberg conducted a combined hearing on all ten decisions, and on May 15, 2026 issued Orders No. 26-UI-330331, 26-UI-330335, 26-UI-330339, 26-UI-330338, 26-UI-330334, 26-UI-330336, 26-UI-330340, 26-UI-330337, 26-UI-330341, and 26-UI-330333, affirming decisions # L0016741698, L0016693869, L0016749080, L0016774760, L0016747889, L0016830212, L0016757570, L0016709946, L0016704361, and L0016760350, respectively.

On May 29, 2026, claimant filed applications for review of ALJ Nyberg's orders with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 26-UI-330331, 26-UI-330335, 26-UI-330339, 26-UI-330338, 26-UI-330334, 26-UI-330336, 26-UI-330340, 26-UI-330337, 26-UI-330341, and 26-UI-330333 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in ten identical copies (EAB Decisions 2026-EAB-0565, 2026-EAB-0562, 2026-EAB-0558, 2026-EAB-0559, 2026-EAB-0563, 2026-EAB-0561, 2026-EAB-0557, 2026-EAB-0560, 2026-EAB-0556, and 2026-EAB-0564).

**ADOPTION OF HEARING ORDER:** EAB considered the entire consolidated hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-330331, 26-UI-330335, 26-UI-330339, 26-UI-330338, 26-UI-330334, 26-UI-330336, 26-UI-330340, 26-UI-330337, 26-UI-330341, and 26-UI-330333's findings of fact, reasoning, and conclusion that

claimant filed late claims for the weeks at issue in those respective orders and therefore was not eligible for benefits for those weeks. Orders No. 26-UI-330331, 26-UI-330335, 26-UI-330339, 26-UI-330338, 26-UI-330334, 26-UI-330336, 26-UI-330340, 26-UI-330337, 26-UI-330341, and 26-UI-330333 are **adopted**. See ORS 657.275(2).

**DECISION:** Orders No. 26-UI-330331, 26-UI-330335, 26-UI-330339, 26-UI-330338, 26-UI-330334, 26-UI-330336, 26-UI-330340, 26-UI-330337, 26-UI-330341, and 26-UI-330333 are affirmed.
