Affirmed
Request to Backdate Denied

PROCEDURAL HISTORY: On March 17, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant’s request to backdate his initial claim to July 27, 2025 (decision # L0016714052). Claimant filed a timely request for hearing. On March 27, 2026, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 13, 2026. On April 13, 2026, claimant failed to appear at the hearing, and ALJ Micheletti issued Order No. 26-UI-326933, dismissing claimant’s request for hearing due to his failure to appear. On April 17, 2026, claimant filed a timely request to reopen the hearing. On May 11, 2026, ALJ Micheletti conducted a hearing that was interpreted into Cambodian, and on May 14, 2026 issued Order No. 26-UI-330224, allowing claimant’s request to reopen the hearing and affirming decision # L0016714052 on the merits. On June 1, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant’s written argument when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-330224’s findings of fact, reasoning, decision to allow claimant’s request to reopen the hearing, and denial of claimant’s request to backdate his initial claim. Order No. 26-UI-330224 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-330224 is affirmed.
