

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0572

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 16, 2025, the Oregon Employment Department (the Department) served notice of wage and potential benefit report concluding that claimant did not have sufficient wages or hours worked to establish a valid claim (decision # L0011206466). On June 26, 2025, decision # L0011206466 became final without claimant having filed a request for hearing. On August 4, 2025, claimant filed a late request for hearing. ALJ Kangas considered the request, and on August 25, 2025 issued Order No. 25-UI-301393, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 8, 2025. Claimant filed a timely response to the appellant questionnaire.

On September 3, 2025, the office of administrative hearings (OAH) issued a letter stating that Order No. 25-UI-301393 was cancelled and vacated, and that a hearing would be scheduled on whether to allow claimant's late request for hearing and, if so, the merits of decision # L0011206466. On September 26, 2025, OAH served notice that the hearing was scheduled for October 9, 2025. On October 9, 2025, ALJ Janzen conducted the hearing, and on October 10, 2025 issued Order No. 25-UI-306801, re-dismissing claimant's late request for hearing as late without good cause, leaving decision # L0011206466 undisturbed. On October 30, 2025, Order No. 25-UI-306801 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 1, 2026, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 25-UI-306801, mailed to claimant on October 10, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-306801 at 3. Order No. 25-UI-306801 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 30, 2025 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-306801 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-306801 was due October 30, 2025. Because claimant did not file her application for review until June 1, 2026, the application for review was late. Claimant’s application for review did not include a written statement describing circumstances preventing her from filing the application for review by the October 30, 2025 deadline. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed June 1, 2026 is dismissed. Order No. 25-UI-301393 remains undisturbed.
