EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0598

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On April 10, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not capable of accepting and reporting for work and therefore not eligible to receive unemployment insurance benefits effective March 22, 2026 (decision # L0016988303). Claimant filed a timely request for hearing. On May 4, 2026, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 19, 2026. On May 19, 2026, claimant failed to appear at the hearing, and ALJ Krueger issued Order No. 26-UI-330583, dismissing claimant's request for hearing due to their failure to appear. On May 19, 2026, claimant filed a timely request to reopen the hearing. ALJ Scott considered claimant's request, and on June 4, 2026, issued Order No. 26-UI-332008, denying the request to reopen as without good cause, leaving Order No. 26-UI-330583 dismissing claimant's request for hearing on decision # L0016988303 undisturbed. On June 13, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-332008's findings of fact, reasoning, and denial of claimant's request to reopen, leaving Order No. 26-UI-330583 dismissing claimant's request for hearing on decision # L0016988303 undisturbed. Order No. 26-UI-332008 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-332008 is affirmed.
