

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0599

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 23, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate their initial claim to December 7, 2025 (decision # L0016164251). Claimant filed a timely request for hearing. On March 10, 2026, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 26, 2026. On March 26, 2026, claimant failed to appear at the hearing, and ALJ Enyinnaya issued Order No. 26-UI-325102, dismissing claimant's request for hearing due to their failure to appear. On April 15, 2026, Order No. 26-UI-325102 became final without claimant having filed a request to reopen the hearing.

On May 11, 2026, claimant filed a late request to reopen the hearing. ALJ Scott considered claimant's request, and on May 15, 2026, issued Order No. 26-UI-330407 denying the request as late without good cause, leaving Order No. 26-UI-325102 undisturbed. On June 4, 2026, Order No. 26-UI-330407 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 13, 2026, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 26-UI-330407, mailed to claimant on May 15, 2026, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 26-UI-330407 at 4. Order No. 26-UI-330407 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 4, 2026 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 26-UI-330407 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-330407 was due June 4, 2026. Because claimant did not file their application for review until June 13, 2026, the application for review was late. Claimant included a written statement with the application for review. However, claimant’s written statement addressed why claimant did not attend the hearing and did not describe circumstances preventing claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed June 13, 2026 is dismissed. Order No. 26-UI-330407 remains undisturbed.
