EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0633

Affirmed
No Disqualification

PROCEDURAL HISTORY: On April 30, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective March 1, 2026 (decision # L0017289545).¹ Claimant filed a timely request for hearing. On June 4 and 9, 2026, ALJ Wahl conducted a hearing, and on June 11, 2026 issued Order No. 26-UI-332551, reversing decision # L0017289545 by concluding that the employer discharged claimant, but not for misconduct, which did not disqualify claimant from receiving benefits. On July 1, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-332551's findings of fact, reasoning, and conclusion that the employer discharged claimant, but not for misconduct, which did not disqualify claimant from receiving benefits. Order No. 26-UI-332551 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-332551 is affirmed.
